Welcome / Introductions

General Welcome & Introductions - Colleen Schwartz

The overall goals of the coalition were shared, and introductions were conducted as there were many new attendees. The overall goal of the coalition is to reduce the risks and prevalence of falls at a population level and there is consensus that this requires a community-based approach. Our formalized Story County Falls Prevention Coalition creates the needed infrastructure to enhance clinical / community collaboration and optimize effectiveness. We welcome broader involvement over time so attendees are encouraged to share.

Announcements / Opportunities

1. Story County Falls Prevention Coalition - Colleen Schwartz

- Announced most action Items from February 2024 meeting were completed (Senior Expo Community Outreach, Fall Screening Events, Instagram and Media Draft Plan, and Promote referrals to HUB to Fall Prevention Programs and Arthritis Appropriate Evidence Based Interventions).
- Shared personal story of Nana who fell over the weekend. She was discharged with no falls prevention information. Staff shared sometimes 10 falls per day come into ER.
- Discussed vision for Story County Fall Prevention Coalition to reflect locally the state vision of: lowans will have fewer falls and fall related injuries, maximizing their independence and quality of life. Our county level work is first in state.
- Discussed need for understanding what falls prevention efforts are being utilized.

- Announced State of Iowa Falls Prevention Symposium September 25, 2024. Our coalition will
 present on the formation of a county wide falls prevention coalition on the University of Iowa

2. Update & Discussion on Clinical and County Fall Prevention Efforts

<u>Inpatient / Primary Care</u> – Matt Peterson shared on behalf of Matt Aitchison on current inpatient fall prevention efforts. Working together on a county falls prevention coalition with evidence-based interventions continues to be a priority.

<u>Emergency Room</u> – Tricia Colman / Sherri Flugrad discussed major factors in falls for prevention efforts. Most falls seem to happen in nursing homes. What is the program delivery there? They commented that a large number of falls (in all ages) are dog related. What is the possibility for increased public awareness? Incidence is also more common in morbidly obese population. What are falls prevention programming strategies for this group?

<u>Home Health / Story County Public Health</u> – Eric Adelmund discussed public senior health screens with fall risk and connection with partners such as MGMC PT, ISU

MGMC Physical Therapy – Matt Petersen encouraged increased frequency and opportunities for collaboration with Story County Public Health and home health. Meetings between Matt, Eric and Greg will continue. He described the equipment to reduce gravity for obese patients to increase physical activity and reduce fall risk. Discussed HIRTA and transportation coalition.

<u>Updated on the Iowa Community HUB</u> – Colleen provided an update of the HUB. Increasing referrals to Arthritis-Appropriate Evidence Based Interventions are a priority. See attached slides on why our involvement in the landscape analysis survey is important.

<u>STEADI Fall Risk Training Course</u> – Greg provided a brief update on the free online training course that his team developed which is now distributed through ISU Extension. Greg and Colleen will be working to enable completion of the course to count for CME and plan to work with ISU Extension and the HUB to enable further sharing of the training.

3. Open Discussion Opportunities

- Dr. Kitchell brought up strategies for referral promotion to trigger BPA in EPIC after fall risk
 establishment in over 65 population. Dr. Kitchell endorsed the Bare Bones / newsletter article
 outreach to medical community. Also, Grand Rounds (with hybrid option) could be timely to provide
 updates on falls prevention. Also interested in how the age adjusted data in the state of Iowa Falls
 data is determined.
- Jenni Talbott was unable to be present but announced (via email) encouragement of Bare Bones.
 She also mentioned that she will introduce the coalition to new CMO, Dr. Shah at the next meeting.
 Discussed upcoming June 4th Clinical Quality meeting that will discuss EPIC workflow possibly identifying hip and/or knee arthritis to connect BPA to HUB / Falls Prevention Arthritis Appropriate Evidence Based Interventions.
- Great discussion was had on focus areas for Story County Falls Prevention Coalition moving into this
 Fall. Improving physical activity and HUB referrals is key to addressing frailty, obesity and arthritis
 connected with falls. A key strategy is to identify frailty diagnosis as well as arthritis. Need to
 identify sedentary populations to address inactivity before risks arise. Can use physical activity vital
 sign as part of in clinic screening.
- 60 Forward building is slated to be open in August. Educational room and classes are being planned.
 Working with MGMC programming. Discussed possibility of having this be the primary location for
 falls prevention education and evidence-based intervention classes (Tai Chi for Arthritis and Falls
 Prevention, Walk With Ease, Matter of Balance) and helpful classes such as gentle yoga.
- Discussed walking and walking track options for Story County.
